

Kashmir International Relief Fund (KIRF) is a non-governmental organization dedicated to providing humanitarian aid and support to the poor and unprivileged segments of society in rural and far-flung areas of Azad Jammu and Kashmir. Established in 1992, KIRF has been working tirelessly to uplift the lives of those in need, providing emergency relief, healthcare services, education, and livelihood support. KIRF also focuses on empowering women through vocational training and other initiatives, enabling them to become self-sufficient and contribute to their communities. With a strong commitment to serving humanity, KIRF continues to make a positive impact in the lives of thousands of people, striving to create a brighter future for the communities it serves.

## AIMS & OBJECTIVES

1. To provide humanitarian aid and assistance to the poor and needy people of Azad Jammu and Kashmir, particularly in rural and far-flung areas.
2. To promote healthcare services, including provision of medical treatment, healthcare facilities, and health education.
3. To provide emergency relief and support to victims of natural disasters, conflicts, and other crises.
4. To promote education and vocational training, particularly for women and children, to empower them and enhance their socio-economic status.
5. To support livelihood initiatives and provide economic opportunities to marginalized communities.
6. To work towards the empowerment of women and girls, and to promote their participation in decision-making processes.
7. To collaborate with local and international organizations, governments, and stakeholders to achieve its objectives.

KIRF is dedicated to provide health care and education to community and innovative programmes especially to empower women to achieve self sufficiency in the rural and far flung areas of Azad Kashmir.

# HISTORY OF KIRF

## History of Kashmir International Relief Fund (KIRF)

Kashmir International Relief Fund (KIRF) has a rich history of serving humanity and providing humanitarian aid to those in need. Established in the early 1990s, KIRF has been working tirelessly to uplift the poor and unprivileged segments of society in rural and far-flung areas of Azad Jammu and Kashmir.

## Early Beginnings (1992)

KIRF's journey began in March 1992, when a group of Kashmiris residing in the UK visited the control line of Azad Jammu and Kashmir and witnessed the dire living conditions of people affected by Indian army firing. Moved by their plight, they established the Kashmir Welfare Association, which later evolved into KIRF.

## Humanitarian Work

Over the years, KIRF has provided relief to migrants in camps, distributed food and clothing to those in need, and initiated projects to provide drinking water schemes, primary schools, and housing support to communities. KIRF has also collaborated with international partners to provide medical assistance and vocational training to women.

## Healthcare Services

KIRF's healthcare initiatives began with running a healthcare unit at Douwarian, District Athmuqam, in collaboration with the Government of Azad Jammu and Kashmir. Additionally, KIRF supplied medicines to BHU Pattikka, District Muzaffarabad, on a monthly basis for patients. KIRF also organized free medical camps and eye camps in different areas of Azad Jammu and Kashmir, starting from 1998, to provide medical care to those in need.

## Qurbani Project

KIRF has been implementing Qurbani projects on Eid ul Adha, distributing meat to poor people in far-flung areas, ensuring that they benefit from this sacred occasion.

## KIRF Community Hospital Jatlan

One of KIRF's most notable achievements is the establishment of the KIRF Community Hospital Jatlan. Founded by Mr. Ishfaq Ahmed, the hospital's foundation stone was laid on March 31, 2003, by Sardar Muhammad Anwar Khan, the then President of Azad Jammu and Kashmir. The hospital became operational on October 1, 2005.



### **Post-Earthquake Relief and Rehabilitation (2005)**

Following the devastating earthquake on October 8, 2005, KIRF provided emergency relief to affected communities in District Rawalakot, Muzaffarabad, and Bagh. KIRF supported the rehabilitation of affected families by providing over 2,000 shelter homes to families in Bagh and Pattikka.

### **Rehabilitation in Samwal Sharif (2006)**

In 2006, KIRF supported the rehabilitation of earthquake-affected families in Samwal Sharif and its surroundings, providing financial assistance to rebuild damaged homes.

### **Earthquake Response in Jatlan (2019)**

When a powerful earthquake struck Mirpur District on September 24, 2019, KIRF Community Hospital Jatlan played a vital role in providing emergency medical services, which helped survive precious lives of injured victims. The hospital's timely medical intervention saved countless lives, and KIRF also provided emergency relief to affected families, including drinking water, food items, and tents, and supported their rehabilitation with financial assistance in collaboration with PakTrust London and Waltham Forest Islamic Association London.

### **Kidney Dialysis Centre Jatlan**

KIRF established a Kidney Dialysis Centre in Jatlan, with construction starting in 2020 and an opening ceremony held on June 10, 2021. The Centre provides free dialysis facilities to kidney failure patients.

### **Flood Relief in Rajanpur (2022)**

During the 2022 floods, KIRF responded to the needs of affected communities in Rajanpur District. A team of volunteers provided medical treatment, meals, and mosquito control measures to prevent malaria. KIRF also installed 50 hand pumps and provided shelter to 50 families.

### **Continued Commitment**

Today, KIRF continues to work tirelessly to serve humanity and provide humanitarian aid to those in need. With a strong foundation built over the years, KIRF remains committed to its mission of uplifting the poor and unprivileged segments of society in rural and far-flung areas of Azad Jammu and Kashmir.

### **Dissolution Of KIRF UK and Partnership with Paktrust London**

Due to internal dispute among trustees, KIRF was dissolved in the UK. However, to continue fundraising efforts, a Memorandum of Understanding (MOU) was signed with Paktrust London on October 30, 2019. This partnership enables KIRF to receive funding and remittances from the UK to support its humanitarian work in Azad Jammu and Kashmir.







### KIRF Community Hospital Jatlan

Located at the confluence of District Mirpur, District Bhimber, Azad Kashmir, and District Jhelum and Gujrat of Punjab, KIRF Community Hospital Jatlan is a 70-bed hospital that serves as a vital healthcare hub for the surrounding communities. With its foundation laid on March 31, 2003, and operationalized on October 1, 2005, the hospital has been providing essential healthcare services to over 200,000 people from approximately 150 villages and hamlets in the four districts.

#### A Testament to Donor Generosity

The hospital's establishment was made possible through the generosity of donors, with 90% of the construction cost contributed by overseas Kashmiri and Pakistani donors residing in the UK. This remarkable example of philanthropy has enabled the hospital to provide critical healthcare services to those in need.



#### Comprehensive Healthcare Services:

KIRF Community Hospital Jatlan operates 24/7, offering a range of vital healthcare services, including:

- 1. Outpatient and Emergency Services:**  
Providing immediate care and attention to patients in need.
- 2. Laboratory Services:**  
Conducting essential tests and examinations to diagnose and treat patients.
- 3. X-RAY and Ultrasound Services**  
Offering advanced diagnostic imaging services to aid in patient care.
- 4. Endoscopy Services:**  
Providing specialized diagnostic and therapeutic services for gastrointestinal conditions.
- 5. Gynae/Obstetrics Department:**  
Delivering essential maternal healthcare services, including prenatal, delivery, and postnatal care.
- 6. Peads Services**  
Providing specialized healthcare services for children, including vaccinations and growth monitoring.
- 7. Nursery (Neonatal Care):**  
Offering critical care and attention to newborn babies.
- 8. Orthopaedic Services:**  
Providing treatment and care for musculoskeletal conditions and injuries.
- 9. ENT Services:**  
Diagnosing and treating ear, nose, and throat conditions.
- 10. Surgical Services:**  
Performing essential surgeries to address various medical conditions.
- 11. ECG**  
Conducting electrocardiogram tests to diagnose and monitor heart conditions.
- 12. Operation Theater:**  
Providing a sterile and safe environment for surgical procedures.

Established on June 10, 2021, the centre has grown to become a vital healthcare resource for the community.

## Our Mission

# Event

## 4TH Anniversary of KIRF Kidney Dialysis Centre Jatlan

On June 10, 2025, the KIRF Kidney Dialysis Centre Jatlan marked a significant milestone, completing four years of operation.

To commemorate this achievement, a ceremony was held at the centre, where President Mehmood Ahmed Raza expressed gratitude to the generous donors who have enabled the centre to provide free dialysis services to patients with kidney failure. Notably, the centre not only offers complimentary dialysis but also provides free blood transfusions and medication.

Mr. Raza congratulated the donors and acknowledged the tireless efforts of the medical staff in delivering exceptional care to patients. Medical Director Dr. Abdul Qudus Akhtar highlighted the centre's accomplishments, revealing that over the past four years, 11,310 dialysis sessions have been conducted. He attributed this success to the kindness of individual donors and partner organisations, including Paktrust London, Waltham Forest Islamic Association London, Ilford Islamic Association London, and Al-Falah Welfare Trust.

During the ceremony, patients and their families praised the centre's services and staff. The event was attended by members, volunteers, family members of patients, and staff, culminating in a cake-cutting ceremony.



# Project in Pipeline

## Paramedics and Nursing Teaching Centre Project

During 2023, Malik Amanat Ali, prominent businessman from Bristol, visited KIRF's healthcare facilities and was impressed by the organisation's commitment to providing free kidney dialysis services to patients in need. Inspired by KIRF's mission, Malik Amanat Ali decided to support the organisation and, in collaboration with Mr. Abdul Raoof Malak Qureshi, organised a fundraising dinner in Bristol UK, which successfully raised Rs. 10,000,000 for the construction of the 1st floor building of the kidney dialysis centre.

The KIRF management utilised these funds to initiate the construction of the Paramedics and Nursing Teaching Centre, contracting Kataria Engineering for the project. This centre will serve as a vital resource for training paramedics and nurses, addressing the healthcare workforce needs in rural communities.

Malik Amanat Ali and Mr. Abdul Raoof Malak Qureshi are continuing their fundraising efforts for the project, and the completion of the building is now in final stage.




# Vocational Training Centres

## Empowering Women through Vocational Training

In today's world, trained and technically equipped human resources are essential for sustainable national development. With women making up almost 50% of the population, empowering them through vocational and technical training is crucial for economic growth and social progress. Kashmir International Relief Fund (KIRF) recognizes the importance of vocational training in rural areas, where access to education and job opportunities is often limited.

## The Need for Vocational Training in Rural Areas

Rural areas face unique challenges, including limited access to education, job opportunities, and economic resources. Vocational training centres (VTCs) can play a vital role in addressing these challenges by providing women with the skills and knowledge necessary to secure employment or start their own businesses. By empowering women through vocational training, KIRF aims to:

- \* Enhance their economic independence and self-reliance
- \* Improve their socio-economic status and contribute to family income
- \* Increase their participation in the workforce and decision-making processes



## KIRF's Efforts

KIRF has established Vocational Training Centres (VTCs) in different rural and far-flung areas of the state, providing training and skills to local women. These VTCs are relocated to different areas when the potential for new students is exhausted, ensuring that KIRF's resources are utilized effectively. Every year, several women complete their training from KIRF VTCs and go on to:

- Work from home or establish their own businesses at local shopping centres
- Earn a reasonable income and share the burden of expenses with their families
- Contribute to the economic development of their communities

## Impact and Importance

KIRF's vocational training programme has a significant impact on the lives of women in rural areas. By providing them with the skills and knowledge necessary to secure employment or start their own businesses, KIRF is empowering them to take charge of their own development. This, in turn, contributes to the economic growth and social progress of their communities. By investing in vocational training, KIRF is investing in the future of women in rural areas, enabling them to become self-sufficient, confident, and economically empowered individuals.

On May 26, 2025, the Vocational Training Centre in Mian Muhammad Town, Mirpur, Azad Kashmir, celebrated a significant milestone with a certificate distribution ceremony for 28 female students who have completed their training in stitching and embroidery. This free-of-charge training programme is designed by KIRF to empower women with valuable skills.

The ceremony was honoured by the presence of President KIRF, Mehmood Ahmed Raza, as the chief guest, accompanied by Secretary Finance, Master Zulfiqar Ali, and Media Advisor, Haji Shahid Iqbal. The event commenced with the recitation of the Holy Quran and a Naat, setting a spiritually uplifting tone.

## KIRF Vocational Training Centre Certificates Distribution Ceremony

KIRF office bearers presented Certificates to the students who have completed the course, and sewing machines were generously gifted to students from underprivileged backgrounds, enabling them to further hone their skills.

President Mehmood Ahmed Raza congratulated the successful students on completing their course and wished them well in their future endeavours. In his address, he encouraged the students to utilise their newfound skills to establish their own boutiques or work from home, thereby contributing to their family's income. Master Zulfiqar Ali provided an overview of KIRF's mission and objectives, highlighting the organisations commitment to empowering the communities. Haji Shahid Iqbal also congratulated the students.



## IV. EMERGENCY RELIEF

Natural disasters such as floods, earthquake, tsunamis, or storms are catastrophic loss of human life, and affects infrastructure. Floods cause devastating effects on property, destruction of crops, loss of livestock and deterioration of health conditions owing to waterborne diseases. These disasters can also traumatise victims and their families for long period of time.

Similarly, the destructive effects of earthquakes cause landslides, tsunamis, fires and fault rupture. The violent shaking of the ground produces the greatest property and personal losses and injuries. In any of the above situation's victims are required immediate relief and afterwards rehabilitation.

The 2022 floods submerged one third of the country, affecting 33 million people, half of them were children. The floods damaged most of the water systems in affected areas, forcing mostly population to rely solely on contaminated water from ponds and Wells. Unsafe water and poor sanitation are key underlying causes of malnutrition.

Kashmir International Relief Fund (KIRF) immediately arranged a team of volunteers headed by Haji Shahid Iqbal Secretary Information KIRF with medical staff to travel to Rajanpur District. The team focused on the different villages of Union Council Janpur. Victims were provided medical treatment and meals for twelve days. Team has also arranged spray to kill mosquitos. The victims were provided mosquito nets and lotion to protect them from malaria .About 50 hand pumps were installed in different villages to provide clean drinking water and 50 families were provided a shelter of one constructed room to each family, with the financial support of donors.



## V. WATER SUPPLY SCHEMES

Safe and readily available Water is important for public health, whether it is used for drinking, domestic use, food production or recreational purposes. Improved water supply and sanitation, and better management of water resources, can boost countries' economic growth and can contribute greatly to poverty reduction.

Keeping in view its importance, KIRF has been creating awareness especially in the wealthy and highly Blessed members of the community to donate for making arrangements of clean water in those areas, where clean water is generally not available. The water schemes already established by KIRF in different areas at different times in Azad Kashmir have played a considerable role in resolving the issue of clean water. The water projects built by KIRF in such a way that not only human beings are being benefited but also very useful for the animals and irrigation purposes.

Pakistan's 2022 monsoon season produced significant rainfall, devastating floods. The floodwater contained sewage and other contamination caused serious health issues. KIRF management sent a team in effected areas of District Rajanpur, where the team arranged to install 50 hand pumps in different villages to provide clean drinking water to the flood victims.



## Commissioner Mirpur Division's Visit To KIRF Community Hospital & Kidney Dialysis Centre Jatlan.

On September 7, 2024, Commissioner Mirpur Division, Government Of Azad Jammun and Kashmir, Ch. Shoukat Ali, Visited KIRF Community Hospital and Kidney Dialysis Centre Jatlan, accompanied by Malik Amanat Ali from Bristol, UK. The Medical Director Dr. Abdul Qudus Akhtar and members of KIRF warmly welcomed them.

During his visit, the Commissioner interacted with patients and reviewed the medical services provided by KIRF. Expressing satisfaction with the services, he noted significant improvements since his previous visit, highlighting the induction of new departments. He particularly appreciated the free kidney dialysis services for patients with kidney failure.

The Commissioner praised KIRF's efficient use of donations, assuring that every penny is rightly spent on supporting poor families. He encouraged the public to support KIRF, enabling the organisation to better serve the underprivileged community.

Mr. M. D. Tahir, former Senior Vice President highlighted the financial burden of kidney dialysis, noting that each session costs about Rs 7000, making it inaccessible to many impoverished patients. The KIRF Kidney Dialysis Centre's free services are thus a vital lifeline for those in need.

Mr. M. D. Tahir thanked the Commissioner for his visit and acknowledged the contributions of donors, particularly Malik Amanat Ali from Bristol, whose efforts enabled the completion of the structure of the second storey's building construction. KIRF's commitment to providing quality medical care to poor patients was reiterated, highlighting the organisation's reliance on donations to sustain its services.



## Visit of Raja Muhammad Ilyas To KIRF Community Hospital and KIRF Kidney Dialysis Centre Jatlan.

On October 17, 2024, Raja Muhammad Ilyas, Secretary General Of Waltham Forest Islamic Association London and Trustee of Paktrust London, Visited KIRF Community Hospital and Kidney Dialysis Centre Jatlan. He was accompanied by Raja Amar Habib. The Visit was also attended by Chairman KIRF, Ch. Rashid Ali, President KIRF Mehmood Ahmed Raza, and other members.

During the Visit, President KIRF briefed Raja Muhammad Ilyas on the services offered to patients and ongoing extension of the second storey building of the kidney dialysis centre. Expressing satisfaction with the medical services, particularly for kidney failure patients, Raja Muhammad Ilyas praised the high standard of care, noting that the services were compered to those in major hospitals, despite the centre's rural location

He extended gratitude to the donors who enabled KIRF to provide such services and appealed for further financial support, citing the increasing number of kidney patients. Raja Muhammad Ilyas also commended the construction progress of the second storey building, thanking the Muslim Community of Bristol, especially Malik Amanat Ali and Mr. Abdul Raoof Malak, for their funding commitments. He noted that 75 % of the promised funding had been fulfilled and encouraged further fundraising efforts to complete the project.

Raja Muhammad Ilyas reaffirmed his commitment to supporting KIRF, promising to continue his support in future.





## Visit of Ch. Muhammad Rizwan (CEO of Seven Stars Group) to KIRF Community Hospital, & Kidney Dialysis Centre Jatlan

On November 5, 2024, Ch. Muhammad Rizwan, CEO of Seven Stars Group, visited KIRF Community Hospital and Kidney Dialysis Centre Jatlan, accompanied by prominent businessmen Ch. Sabar Hussain, Abdul Hafeez, and Muhammad Maqsood Awan from Muzaffarabad. The visitors were warmly welcomed by Chairman KIRF Ch. Rashid Ali, President Mehmood Ahmed Raza, Medical Director Dr. Abdul Qudus Akhtar, Kidney Dialysis Centre's Incharge Dr. Adeel Zaman, members, and volunteers of KIRF.

**1- Status and Principal Activities**

**Kashmir International Relief Fund** was registered with Azad Govt. of the State of Jammu & Kashmir Directorate of Social Welfare Muzaffarabad, The AJ&K Charity Commission Confers Provisional Registration in terms of Section 17 (1) of the AJ&K Charities Registration, Regulation & Facilitation Act, 2020 in favour of Kashmir International Relief Fund under the Azad Jammu & Kashmir Council Extension of Voluntary Social Welfare Agencies (Registration and Control) Act, 1982 on **13<sup>th</sup> day of June, 2005**. The registered office of **Kashmir International Relief Fund** is situated at Mirpur Azad Kashmir. **Kashmir International Relief Fund Hospital Jatlan, Mirpur Azad Kashmir** is a project of **Kashmir International Relief Fund** is also supervising/sponsoring different welfare projects through **Field Office, Bagh, Azad Kashmir**. The main object of **Kashmir International Relief Fund** is to promote charity in and among communities and people of Azad Kashmir and Pakistan and of other countries of the World.

**2- Statement of Compliance**

These financial statements have been prepared in accordance with accounting policies as adopted by Board of Governance.

**3- Summary of Significant Accounting Policies**

**3.1- Basis of Preparation**

These financial statements have been prepared under the historical cost convention.

**3.2- Income and Expenditures Recognition**

- a) Income from Donation / Aids and Charity, Hospital Income and Other Income are recognized on its receipt in cash.
- b) All expenditures are recorded on accrual basis.

**3.3- Provision**

A provision is recognized in the Balance Sheet when the Kashmir International Relief Fund has a legal or constructive obligation as a result of a past event, and it is probable than an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of obligation.

**3.4- Taxation**

Provision for taxation has not been made in these financial statements. The NPO has been applied for exemption under Clause (36) of Section 2 of the Income Tax Ordinance, 2001.

**3.5- Tangible Fixed Assets**

All fixed assets are stated at cost less accumulated depreciation.

Depreciation is charged on reducing balance method on the rates stated in fixed assets schedule.

Full year depreciation charged on addition made during the year and no depreciation is charged in the year of disposal of the assets.

### 3.6- State of Financial Record

The Managing Committee who supervises the day to day affairs of NPO have assured us about the authenticity of the facts and figures taken in these financial statements, therefore, we have accepted the assurance as estimates/details provided appear to be genuine.

### 3.7- General

- i) Figures in these financial statements have been rounded off to the nearest rupee.
- ii) Prior year figures have been re-grouped / re-arranged wherever necessary for the purpose of comparison




